

Tishas Merdeka Kids Coloring Contest Terms & Conditions

1. Tishas Merdeka Kids Coloring Contest is applicable to kids aged 4 years old to 12 years old as of 2018.

- **Category 1** is open to kids aged 4 years old to 6 years old (as of 2018)
- **Category 2** is open to kids aged 7 to 9 years old (as of 2018)
- **Category 3** is open to kids aged 10 to 12 years old (as of 2018)

2. Parents need to purchase Tishas Roti Paratha minimum **3 packets** to entitle to join the contest.

3. **One (1) receipt entitles contestant to one (1) online participation.** Keep original receipt as proof of purchase and **ONLY** original printed receipts will be accepted.

4. Winners will be determined based on the most creative photos received within Contest Period. Prizes will be awarded to the Contest winners based on creativity and overall attractiveness of the artwork. 1st, 2nd, 3rd and **consolidation winners for all categories will be chosen 50% by TFMSB and 50% by social media vote.**

5. 3 winners for each category shall be entitled to the following prizes: Kids Coloring Contest Final Round Prizes (for each category (Cat 1, Cat 2 & Cat 3)):

- 1st Winner - RM500 cash
- 2nd Winner - RM300 cash
- 3rd Winner – RM200 cash
- 10 Consolidation prize – RM50

6. Participants are required to provide correct and valid personal information in order to validate the registration for the contest. Any unclear or incomplete details will make the participation void.
